2. Vendors will provide a copy of the Department of Health License for the day.
3. Vendor will provide a copy of insurance coverage per individual carrier.
4. Vendors' set-up is on Saturday, Monday, September 2nd, starts at 9 am and must be completed by 10 am.
5. Donate a door prize (optional). Donations are good for advertising your business.
6. Additional display items are allowed within your space.
7. **First come...First serve on vendor space.**
8. Weather Conditions: **REFUNDS WILL NOT** be issued because of inclement weather. The event will **PROCEED** regardless of weather conditions.
9. Vendors and participants will release the Event organizers and affiliates of **ANY** and **ALL** liability and claims that may arise from **ANY** injuries, damages or losses suffered or incurred by you or to your property in connection with this event.
10. Failure to comply with the above rules is considered a breach of contract agreement and shall result in the termination of this contract, removal from the premises and forfeiture of deposit and / or event participation monies.
